Overview of ERS Enrollment Reporting Schedule: 2008-2009

Data File Collection: ERSA, ERSO, ERSS, and APDB

- Preliminary ERS files are due one week after the term census date.
- Final summer ERS files are due 15 working days after the fall term census date.
- Final fall profile ERS files are due 15 working days after the fall term census date.
- Winter and spring profile files are due 15 working days after the term census date.
- Profile APDB files are due 30 working days after the term census dates.
- Final ERS and APDB data files for fall, winter, and spring are due June 15, 2009.

Data File Collection: ERST, ERSD, and sERSS

- ERST files for CY 2007-2008 (July 1, 2007-June 30, 2008) are due November 3, 2008.
- ERST files for CY 2008-2009 (July 1, 2008-June 30, 2009) are due November 2, 2009.
- ERSD files containing fall, winter, and spring degrees for CY 2007-2008 are due August 14, 2008.
- ERSD files containing summer degrees for CY 2008-2009 are due November 3, 2008.
- ERSD files containing fall, winter, and spring degrees for CY 2008-2009 are due August 13, 2009.
- sERSS final term files (summer 2008, fall 2008, winter 2009, and spring 2009) are due on June 15, 2009.

Other Reports

Besides ERS files, campuses must transmit four supplementary datasets that facilitate reporting for Board of Trustees, spring IPEDS, and enrollment planning.

One-Year Later Proficiency File (Fall 2007 to Fall 2008)

Due on October 1, 2008 this file contains academic and enrollment outcomes for students that held first-time freshmen status in the previous fall term (fall 2007) and were not proficient in either English or math. An electronic memorandum is sent out each year specifying the protocol for the transmission.

Final Fall ERSA File for First-Time Freshmen Only (Fall 2008)

Due on March 2, 2009, this final file should include all applications received for the previous fall term (Fall 2008) for first-time freshmen only.

Preliminary Fall ERSA File for First-Time Freshmen Only (Fall 2009)

Due on March 2, 2009, this in-progress file represents applications received for the next fall term (Fall 2009) as of March 2, 2009. An electronic memorandum is sent out each year specifying the protocol for the transmission.

Monthly Report of Applications

Campuses are no longer required to report monthly counts of applications to the Analytic Studies division of The Chancellor's Office. Monthly Application reports are now received from XAP. The following website can be accessed to view historical application counts:
