

Catastrophic Leave Donation Chart

The CSU Catastrophic Leave Donation Program allows employees who earn sick and/or vacation leave credits to voluntarily donate those credits to employees that are totally incapacitated due to a catastrophic illness or injury, and have exhausted all leave credits, including any sick, vacation, personal holiday or CTO credits. Family illnesses that are deemed catastrophic, requiring an employee to be absent to care for an immediate family member, are also eligible for the CSU Catastrophic Leave Donation Program.
