Rental Rates for Housing Facilities  
Executive Order No. 223

A. Effective July 1, 1975, fees on housing facilities governed by Article 5 (commencing with Section 42000) of Subchapter 5, Chapter 1, Part V, Title 5 of the California Administrative Code, shall be charged in accordance with the following schedule of rates, which include board rates, where specified.
