

Subject: Management Personnel Plan and Confidential Classifications: Fiscal Year 2000/2001 Salary Range Adjustments

Salary ranges for Management Personnel Plan (MPP) and Confidential (C99) classifications have been adjusted effective July 1, 2000, as noted in Attachments A and B.

These salary range adjustments will have no effect on an individual pay rate unless an employee is currently below the minimum of the new salary range. An employee may not have a pay rate lower than the minimum of the range in effect as of July 1, 2000. Campuses will be responsible for adjusting the assigned salary rate for these employees.

MPP and Confidential Employee Merit Salary Increase Program information was provided to presidents in a separate correspondence. Merit salary increases are effective July 1, 2000. Campus payroll processing may proceed beginning July 17, 2000. Merit increases for general or non-state funded MPP and Confidential employees should be processed using the salary rate change (SCR) transaction with a Detailed Transaction Code (Item 719) of "50". If an employee's salary was at the maximum of the previous range and is now below the maximum of the new range, the anniversary date (Item 330) must be changed from "MAX" to "9999".

As a reminder, in-classification and salary increases within a skill level also are available to Confidential employees as outlined in HR 96-15, Supplement #1.
