Subject: **CSU Salary Schedule Changes – Payscale Modifications**

California State University Employees' Union (CSUEU) – Units 2, 5, 7 and 9

Pursuant to a Side Letter of Agreement, the paycales will be modified to incorporate implementation of the Interpreter Series, Realtime Captioner Series and Computer-Aided Transcribers in Unit 9 (Technical Support). Changes include updated classification standards for the Interpreter Series (formerly Interpreter/Transliterators) and implementation of new classifications for Realtime Captioner and Computer-Aided Transcribers. Refer to HR 2006-19 and Technical Letter HR/Salary 2006-14 for additional information. Payscale changes are effective August 2, 2006:
