



**Executive Vice Chancellor and Chief Academic Officer**

Chief administrative and academic officer for the California State University system. Serves as the principal academic strategy and policy advisor to the chancellor. Reports to the chancellor.

**2962**

**Executive Vice Chancellor and Chief Financial Officer**

Chief administrative and fiscal officer for the California State University system. Serves as the principal business and financial strategy and policy advisor to the chancellor. Reports to the chancellor.

**2943**

**Vice Chancellor, University Advancement**

Chief advancement and public affairs officer for the California State University system. Serves as the principal development strategy and policy advisor to the chancellor. Reports to the chancellor.

**2966**

**General Counsel**

Chief legal counsel for the California State University system. Serves as the principal legal advisor to the chancellor. Reports to the chancellor and has a dotted line to the Board of Trustees.

**2973**

**Vice Chancellor, Human Resources**

Chief human resources officer for the California State University system. Serves as the principal human resources strategy and policy advisor to the chancellor. Reports to the chancellor.
