Subject: 2011-12 Tuition Fee Increase


As you are probably aware, the State of California has made another reduction to the CSU budget. The CSU faces at least a \$650 million budget cut and an additional mid-year cut of \$100 million if state revenue forecasts are not met.

At its meeting held on July 12, 2011, the CSU Board of Trustees approved a 2011-12 tuition fee increase of 12%. This means that the tuition fee will increase for all CSU students effective fall term 2011. Please refer to the attachment "2011-12 Tuition Fee Increase Summary" for the specific amounts of the new tuition rates for undergraduates, credential, and graduate students. Please review the form, choose a payment option and return the form to us with your signature by August 1, 2011.

We recognize that this added cost will be a financial challenge for you. The Office of International Programs will work with you in coming up with a payment plan for the additional cost. For those of you who are on financial aid, please contact your campus financial aid office to see if additional funds may be awarded to cover the increase.

If there are further adjustments or updates regarding the fee increase, we will notify you by email as soon as possible. Please be sure to check your email regularly. If you have questions, please contact Joyce Cury or Sharon Okashima in our office at (562) 951-4790.
