Subject: 2004-05 State University Fee Levels for Credential Program Participants

This memorandum supersedes AA-2004-21. The CSU Board of Trustees has established a fee schedule for the 2004-05 academic year that increases the State University Fee for qualified postbaccalaureate teacher credential program participants by 20 percent and for other postbaccalaureate and graduate students by 25 percent. The fee schedule is attached. For postbaccalaureate and graduate students enrolled in colleges of education, the fee level will be assessed as follows:

A postbaccalaureate or graduate student will be subject to the State University Fee for "teacher credential program participants" if

The student is seeking a Multiple Subject, Single Subject, or Special Education teaching credential (preliminary, clear, Level I, or Level II) and has been admitted to a credential program with classified or conditionally classified status.

A postbaccalaureate or graduate student will be subject to the State University Fee for "graduate" students if

- The student already possesses a basic teaching credential and is seeking a second education credential, or
- The student is seeking a Designated Subjects credential; or

- The student already possesses a basic teaching credential and is seeking additional introductory or specific subject matter authorization; or
- The student has not been admitted to a Multiple Subject, Single Subject, or Special Education teaching credential program with classified or conditionally classified status; or
- The student is simultaneously enrolled in a Masters Degree program and a Multiple Subject, Single Subject, or Special Education teaching credential program.

Please note that an *undergraduate* student who is enrolled in a blended or integrated teacher credential program will be subject to the State University Fee for “undergraduates”; a student who was admitted to a blended or integrated teacher credential program as an undergraduate but who has been awarded the bachelor’s degree and readmitted as a postbaccalaureate student to complete the blended or integrated credential program requirements will be subject to the State University Fee for “credential program participants.”

Please also note that 20 percent rate increase applies only for “teacher” credential program students, that is, for students in Multiple Subject, Single Subject, or Special Education Credential programs. Other “service” credentials program students (e.g., Education Administrative Services) are treated as graduate program students and the 25 percent rate applies.
