Chair Pesqueira called the meeting to order at 3:30 p.m.

Approval of Minutes

The minutes of May 16, 2001, were approved as submitted.

Vice Chancellor McClain introduced Samuel Strafaci, Assistant Vice Chancellor, Human Resources. Mr. Strafaci stated that the Statewide University Police Association (Unit 8) and the Union of American Physicians & Dentists (Unit 1) had reached tentative agreements for new three-year contracts. He also stated that three contracts are under negotiations: State Employees Trades Council (Unit 6), California State Employees Association (Units 2, 5, 7 & 9) and the California Faculty Association (Unit 3).

Mr. Strafaci recommended ratification for Units 1 and 8.

Trustee Campbell moved to ratify Units 1 and 8. Motion was seconded. Motion passed.

The meeting then went into closed session pursuant to Government Code section 3596[d].
