SUBJECT: 2002/03 Additional Enrollment Allocations

The allocations made in this memorandum reflect budget decisions regarding the additional one-percent enrollment funding CUS received in the 2002/03 Final Budget.

Campuses are scheduled to receive allocations orders from CSU Financial Services between November 5th and December 9th. The allocations will reflect increased General Fund appropriations at \$6,488 per FTES and CSU calculations for anticipated State University Fee revenue associated with the additional enrollment growth based on the most recent past year enrollment experience, which is the same process used for the 2002/03 Final Budget allocations. It is expected that campuses will set-aside appropriate funds from their increased revenue to address the needs of students eligible for financial assistance.

The campus allocations identified in Attachment A of this memorandum will become permanent in the 2003/04 Final Budget as a base budget adjustment. At that time, an amount equivalent to \$409 per FTES will be transferred from campuses budgets to the systemwide State University Grant program to reflect CSU budget policy regarding increased State University Fee revenue.
