**Re:** Category III Fee – CSU Chico Nursing Course Fees

---

This budget office coded memorandum authorizes California State University, Chico to revise its Category III miscellaneous course fees for the campus nursing program starting in 2017-18 as shown in the attached table. These fee amounts have been approved by the campus student fee advisory committee and are being increased to offset increasing program costs. Additionally the fee change aligns costs more evenly across the ten nursing courses.

While new fee amounts are approved for 2017-18, 2018-19, and 2019-20, the campus student fee advisory committee shall be consulted prior to implementation of 2018-19 and 2019-20 fee increases to ensure that course fees do not increase if actual costs are not also increasing. Because six of the ten course fees exceed the approved miscellaneous course fee range set in CSU Student Fee Policy, Executive Order 1102, Section VI.C.6., any increases to those course fees beyond the amounts approved in this memo for each year, or increases for subsequent years, must be approved by the chancellor's office.
