Chairperson Koester called the meeting to order at 2:05 PM.

#### Item 1 – CSU Institute Board Minutes – June 24, 2021 (Action)

Chairperson Koester queried the Board for comments regarding the June 24, 2021 CSU Institute Board of Directors meeting minutes. Hearing no questions or comments, Chairperson Koester requested a motion to approve the minutes. Ms. Redfearn moved to approve the minutes. Ms. Freedman seconded the motion. Approved 4-0.

#### Item 2 – CSU Institute Board Minutes – June 29, 2022 (Action)

Chairperson Koester queried the Board for comments regarding the June 29, 2022 CSU Institute Board of Directors meeting minutes. Hearing no questions or comments, Chairperson Koester requested a motion to approve the minutes. Ms. Redfearn moved to approve the minutes. Ms. Freedman seconded the motion. Approved 4-0.

Ms. Richardson informed the Board of Directors of Director Leora Freedman and Director Lori Redfearn's appointments to the Board in accordance with the CSU Institute Bylaws.

### Item 4 – Acceptance of June 30, 2022 Audited Financial Statements (Information)

Ms. Richardson informed the Board that the CSUI Audit Committee met on September 20, 2022 with KPMG to review the June 30, 2022 audited financial statements. The Audit Committee found no issues associated with the financial statements. Ms. Richardson stated that the CSU Institute Audit Committee reviewed and approved the financial statement during the September 20, 2022 meeting for presentation to the CSUI Board of Directors.

# <u>Item 5 – Update on the California State University Commercial Paper Program (Information)</u>

Mr. Eaton presented the prepared information item as an update for CSU Institute Board of Directors regarding commercial paper activity. Mr. Eaton stated that the current commercial paper portfolio has a balance \$99,591,000 at a weighted average interest rate of 2.96%. The current portfolio is composed of two projects financed with commercial paper over short to intermediate term instead of long-term Systemwide Revenue Bond (SRB). Since the last report to the Board in June 2022, the portfolio balance has decreased by \$15,779,000 (from \$115,370,000 to \$99,591,000) based on series of CP events: redemption of CP using campus revenue; amortization of principal for certain project subject to shorter term financing through CPs; and increase in CP principal from CP rolls. CP pipeline is projected to remain at current level through February 2023.
