Rental Rates for Housing Facilities
Executive Order No. 192

A. Effective January 1, 1974 rentals on housing facilities governed by Article 5, (commencing with Section 42000) of Subchapter 5, Chapter 1, Part V, Title 5 of the California Administrative Code, shall be charged in accordance with the following schedule of rates, which include board rates, where specified.

(a) Family Dwelling Units

Two-bedroom unit	
California State University, San Jose	60.00
California State University, San Francisco	60.00
All other State Universities and Colleges	60.00
One-bedroom unit	42.00
One-bedroom unit California State University, San Jose	60.00
Units without separate bedroom	37.00
One-bedroom unit without separate kitchen	40.00

These rental rates include essential furniture and utilities, except that, in any project of 100 or more family dwelling units in which there are installed individual unit electric and gas meters and the licensees pay the utility companies directly, the rental rate may be reduced by \$7.50 per month per dwelling unit.
