
This Executive Order is issued pursuant to Board of Trustees Resolution adopted July 1963 (Minutes, pp. 604-605).

Effective immediately, the President of California Polytechnic State University, San Luis Obispo is authorized to delegate to such administrative officers of said campus as he shall designate, the authority to sign checks drawn on the Leopold Edward Wrasse Loan Fund and the Leopold Edward Wrasse Scholarship Fund. Such delegation shall identify the method and circumstances under which the delegated authority may be exercised. The delegation shall also provide for regular review by the President of the actions taken pursuant to said delegation.

The President shall from time to time, as appropriate, forward to the Office of the Chancellor the names of those administrative officers authorized to sign said loan and scholarship checks.

To the extent that provisions of Executive Order 1 are inconsistent with this Order, such provisions are hereby superseded.
