Executive Order No: 248
Title: Rental Rates For Housing Facilities
Effective Date: July 1, 1976
Supersedes: Executive Order No. 223 as amended on February 4, 1976

Effective July 1, 1976, license fees for housing facilities governed by Articles 5 and 6 (commencing with Section 42000) of Subchapter 5, Chapter 1, Part V, Title 5 of the California Administrative Code, shall be charged in accordance with the following schedule of rates, which include board rates, where specified.

1. RESIDENCE HALLS

Rates include all facilities unless otherwise specified.
