**Executive Order No.:** 287

**Title:** Student Body Center Fee  
California State University, Hayward

**Effective Date:** February 22, 1978

**Supersedes:** Executive Order No. 284

Effective with the 1977/78 Winter Quarter, the Student Body Center Fee Schedule requested by California State University, Hayward is approved for implementation. This action is taken pursuant to Chapter III, Section 6, subdivision "d" of the Standing Orders of the Board of Trustees.

Notwithstanding the other provisions of this Executive Order, upon the commencement of use of any student body center, or any part thereof, for which compulsory fees have been charged, and which is financed in whole or in part through the proceeds of revenue bonds issued and sold pursuant to the State College Revenue Bond Act of 1947, fees shall no longer be collected for such student body center pursuant to Education Code Sections 89303 and 89304, but shall, instead, be charged as herein authorized, pursuant to Education Code Section 90012, subdivision (c) and Education Code Section 90068. The amount of such fees shall be the same as had been charged and assessed immediately prior to such commencement of use, and may thereafter be changed only on authorization of the Chancellor.
