

Executive Order No. 324

Title: Student Body Center Fee and Study Body Association Fee Schedule, California State College, San Bernardino

Effective Date: April 1, 1980

Supersedes: Executive Orders No. 249 and 291

Effective Spring, 1980, the revised Student Body Center and Student Body Association Fee Schedule requested by California State College, San Bernardino is approved for implementation. The fee schedule authorized herein shall supersede all such fees previously authorized for California State College, San Bernardino. This action is taken pursuant to Chapter III, Section 6, subdivisions "c" and "d" of the Standing Orders of the Board of Trustees.


The student body organization fees shall be collected in the amount specified in this Order, except as otherwise provided in individual cases, pursuant to Education Code Section 89300.

The student body center fees shall be charged as herein authorized, pursuant to Education Code Section 90012 subdivision (c) and Education Code Section 90068.
