

Supersedes: Executive Order No. 323 as it relates to fees for Spring, 1982 and thereafter


Effective with the Spring Semester, 1982, the Student Body Center Fee Schedule requested by California State University, Fresno is approved for implementation. The fee schedule authorized herein shall supersede all such fees previously authorized for California State University, Fresno. This action is taken pursuant to Chapter III, Section 6, subdivision "d" of the Standing Orders of the Board of Trustees.

Fees shall be charged as herein authorized, pursuant to Education Code Section 90012, subdivision (c) and Education Code Section 90068.
