Effective with the commencement of the Fall Quarter, 1981, the Student Body Association Fee Schedule requested by California Polytechnic State University, San Luis Obispo is approved for implementation. Student Body organization fees shall be collected in the amounts specified in this Order, except as waived in individual cases, pursuant to Education Code Section 89300. This action is taken pursuant to Chapter III, Section 6, subdivision "c" of the Standing Orders of the Board of Trustees.


