Title: Student Body Association Fee
California State University, Fullerton

Effective Date: January 27, 1982

Supersedes: Executive Order No. 127 as it relates to the Student Body Association Fee

Effective with the commencement of the Spring Semester, 1982, the Student Body Association Fee Schedule requested by CSU, Fullerton is approved for implementation. Student Body organization fees shall be collected in the amounts specified in this Order, except as waived in individual cases, pursuant to Education Code Section 89300. This action is taken pursuant to Chapter III, Section 6, Subdivision "c" of the Standing Orders of the Board of Trustees.
