

Title: Student Body Center Fee Schedule
California State College, San Bernardino

Effective Date: May 27, 1982


Supersedes: Executive Order No. 324 as it relates to the Student Body Center Fee

Effective Fall, 1982, the revised Student Body Center Fee Schedule requested by California State College, San Bernardino is approved for implementation. The fee schedule authorized herein shall supersede all such fees previously authorized for California State College, San Bernardino. This action is taken pursuant to Chapter III, Section 6, subdivisions "c" and "d" of the Standing Orders of the Board of Trustees.

The student body center fees shall be charged as herein authorized, pursuant to Education Code Section 90012 subdivision (c) and Education Code Section 90068.
