



Executive Order No.: 467
Title: Student Body Center Fee
California Polytechnic State University, San Luis Obispo
Effective Date: September 20, 1985
Supersedes: Executive Order No. 383

Effective with the Winter Quarter, 1986, the Student Body Center Fee Schedule requested by California Polytechnic State University, San Luis Obispo is approved for implementation. The fee schedule authorized herein shall supersede all such fees previously authorized for California Polytechnic State University, San Luis Obispo. This action is taken pursuant to Chapter III, Section 6, subdivision "d" of the Standing Orders of the Board of Trustees.

Fees shall be charged as herein authorized pursuant to Education Code Section 90012, subdivision (c) and Education Code Section 90068.


