**Subject:** Measles and Rubella Immunizations — Health Screening Programs — Executive Order No. 469

I am transmitting to you a copy of Executive Order No. 469 regarding measles and rubella immunizations. The purpose of this Executive Order is to reduce the likelihood of outbreaks of these diseases on California State University campuses. This Executive Order specifies those groups of students who shall be required to provide proof of immunization and prescribes procedures for implementation.

While students should be encouraged to obtain acceptable proof of immunization from family physicians or community medical providers, those students unable to present such documentation shall have the opportunity to be immunized at the Campus Health Center at no cost to the students.

Campuses are encouraged to inform feeder schools in their service areas about this requirement.

The President has the responsibility for implementing this Executive Order and for maintaining the campus repository and index for all Executive Orders.

**Executive Order No.:** 469  
**Title:** Measles and Rubella Immunizations — Health Screening Programs  
**Effective Date:** December 17, 1985  
**Supersedes:** No Prior Executive Order

This Executive Order is issued pursuant to Sections 1 and 2 of Chapter III of the Standing Orders of the Board of Trustees and Section 41200 of Title 5 of the California Administrative Code.

All new students for fall term 1986 born after January 1, 1957 and students born after January 1, 1957 applying for readmission for fall term 1986, shall be notified of the requirement to present proof of measles and rubella immunizations by the beginning of the next term at the campus of enrollment. At the beginning of the next term (either winter quarter or spring semester 1987) those found not to be in compliance shall be notified further of the need to comply before receiving registration materials to enroll for the succeeding term (either spring quarter or fall semester 1987).

In addition, proof of measles and rubella immunizations shall be required for certain groups of enrolled students who have increased exposure to these diseases. These groups include students who reside in campus residence halls, students whose primary and secondary schooling were obtained outside the United States and students who are enrolled in dietetics, medical technology, nursing, physical therapy and any practicum, student teaching or field work involving preschool-age children, school-age children or taking place in a hospital or health care setting.

Should students be unable to obtain acceptable proof of immunizations, Student Health Centers, in cooperation with the county health association, shall provide immunizations without cost to the students.

Each campus shall develop an appropriate immunization form compatible with the county health association requirements and maintain these forms as part of student health records. The immunization form shall include provisions for medical and religious exemptions.

Each campus shall continue to conduct appropriate informational and health education programs about the dangers of measles and rubella.
