**Title:** Student Body Center Fee — California Polytechnic State University, San Luis Obispo  
**Effective Date:** May 5, 1986  
**Supersedes:** Executive Order No. 467

Effective with the Summer Quarter, 1986, the Student Body Center Fee Schedule requested by California Polytechnic State University, San Luis Obispo is approved for implementation. The fee schedule authorized herein shall supersede all such fees previously authorized for California Polytechnic State University, San Luis Obispo. The action is taken pursuant to Chapter III, Section 6, subdivision "d" of the Standing Orders of the Board of Trustees.

Fees shall be charged as herein authorized pursuant to Education Code Section 90012, subdivision (c) and Education Code Section 90068.
