Subject: Student Body Association Fee, California State University, Dominguez Hills —
Executive Order No. 497

I am transmitting to you a copy of Executive Order No. 497 which authorizes the establishment of the Student Body Association Fee Schedule requested by California State University, Dominguez Hills.

The student referendum approving an increase in the Student Body Association Fee also discussed use of the funds to support a child care facility. Use of the Associated Students' funds for child care centers is permitted by Title 5, California Administrative Code, Section 42659 (o). The revenue from this fee, however, may be used for any purpose approved by the Trustees and is subject to regular allocation and appropriation procedures applicable to the Student Body Association.

Also, pursuant to the student referendum, the attached Executive Order implements an increased fee level for a period of three years, with the fee reverting to the previous level effective Fall Semester, 1989.

In accordance with The California State University policy, the campus President has the responsibility for implementing Executive Orders where applicable and for maintaining the campus repository and index for all Executive Orders.

Title: Student Body Association Fee
 California State University, Dominguez Hills
Effective Date: September 8, 1986
Supersedes: Executive Order No. 478

Effective with the commencement of Fall Semester, 1986, the Student Body Association Fee Schedule requested by California State University, Dominguez Hills is approved for implementation. Student Body organization fees shall be collected in the amounts specified in this Order, except as waived in individual cases, pursuant to Education Code Section 89300. This action is taken pursuant to Chapter III, Section 6, subdivision "c" of the Standing Orders of the Board of Trustees.
