**Subject:** Student Body Association Fee, California State College, Bakersfield — Executive Order No. 513

I am transmitting to you a copy of Executive Order No. 513 which authorizes the establishment of the revised Student Body Association Fee Schedule for California State College, Bakersfield. The fee increase is being implemented based on the intent of the favorable election conducted by the Associated Students and on the material submitted with your May 26, 1987 request.

The student referendum approving an increase in the Student Body Association Fee discussed use of the funds to support athletics. Use of the Associated Students funds for athletics is permitted by Title 4, California Administrative Code, Section 42659. The revenue from this fee, however, may be used for any purpose approved by the Trustees and is subject to regular allocation and appropriation procedures applicable to the Student Body Association.

In accordance with The California State University policy, the campus President has the responsibility for implementing Executive Orders where applicable and for maintaining the campus repository and index for all Executive Orders.

Title: Student Body Association Fee, California State College, Bakersfield  
Effective Date: September 4, 1987  
Supersedes: Executive Order No. 454

Effective with the commencement of the Fall Quarter, 1987, the Student Body Association Fee Schedule requested by CSC, Bakersfield is approved for implementation. Student Body organization fees shall be collected in the amounts specified in this Order, except as waived in individual cases, pursuant to Education Code Section 89300. This action is taken pursuant to Chapter III, Section 6, subdivision "c" of the Standing Orders of the Board of Trustees.
