 Title: Student Body Center Fee Schedule  
 San Diego State University  
 Effective Date: May 16, 1988  
 Supersedes: Executive Order No. 332

Effective Fall Semester 1988, the revised Student Body Center Fee Schedule requested by San Diego State University is approved for implementation. The fee schedule authorized herein shall supersede all such fees previously authorized for San Diego State University. This action is taken pursuant to Chapter III, Section 6, Subdivision "d" of the Standing Orders of the Board of Trustees.

The Student Body Center Fee shall be charged as herein authorized, pursuant to Education Code Section 90012, subdivision (c) and Education Code Section 90068.
