

Subject: State University Fee - Executive Order No. 549

I am transmitting to you a copy of Executive Order No. 549 which establishes the State University Fee commencing with the Fall 1989 term.

This Executive Order supersedes the fee schedule approved by the Board of Trustees at its March 8, 1989 meeting (RFIN 03-89-04), and is issued in accordance with the authority delegated to the Chancellor by the Board of Trustees in October, 1988 (RFIN 10-88-07). The schedule in the Executive Order is a reduction of the fee presently in effect. The revised fee schedule authorizes a 3.6 percent State University Fee increase, 6.4 percentage points less than the currently authorized level.

You will note that although the Executive Order is effective immediately, the fee established by the Executive Order applies to academic terms commencing with the Fall 1989 term. Any rebates students are due as a result of this fee adjustment should be provided as expeditiously as possible.

It is your responsibility as President to implement Executive Order No. 549 where applicable and to maintain the campus repository and index for all Executive Orders.

 Title: State University Fee
 Effective Date: July 12, 1989
 Supersedes: No Prior Executive Order

In accordance with the authority delegated to the Chancellor by the Board of Trustees in October, 1988 (RFIN 10-88-07) regarding the 1989/90 Support Budget and pursuant to passage of the Budget Act of 1989 as adopted by the California State Legislature under signature of the Governor, the State University Fee schedule for the 1989/90 academic year, effective with the Fall 1989 term and until further amended, shall be as follows:


1. All campuses, except California State University, Stanislaus:

0 to 6.0	\$204	\$136	\$408
6.0 or More	\$354	\$236	\$708

2. California State University, Stanislaus:

Units	Per Semester	Winter Term	Per Academic Year
All Students:			
0 to 6.0	\$176	\$ 56	\$408
6.0 or More	\$326	\$ 56	\$708

This fee schedule should be implemented immediately.
