**Subject:** Fees for Housing Facilities — Executive Order No 559 Revised

I am transmitting to you a revised copy of Executive Order No. 559 which establishes the 1990/91 room and board license fees for the California State University housing system. This revision will replace Executive Order No. 543, dated June 20, 1989.

This revision corrects the double room license fee at California State University, Long Beach. In addition, the ten meal board fee at San Diego State University has been revised pursuant to the campus request.

In accordance with the policy of the California State University, the campus president has the responsibility for implementing executive orders where applicable and for maintaining the campus repository and index for all executive orders.

**Title:** Fees for Housing Facilities  
**Effective Date:** July 17, 1990  
**Supersedes:** Executive Order No. 543

This executive order is issued pursuant to Education Code Sections 89700, 90012, and 90068 as delegated in Section 42004 of Title 5, California Administrative Code and Section 6-e of Chapter III of the Standing Orders of the Board of Trustees.

Effective July 1, 1990, fees for housing facilities governed by Article 5 (commencing with Section 42000) of Subchapter 5, Chapter 1, Part V, Title 5 of the California Administrative Code shall be charged in accordance with the schedule below.

Board fees and frequency of meals are not set by this executive order and are provided below for information only. Individual campuses should be contacted regarding the period covered by housing and board fees.

**5. SERVICE FEE**

Service fee means a nonrefundable fee required of a licensee to cover the added costs incurred in collecting and processing a license fee by installments (Title 5, Section 42000 (i)).

\$4 ↔ \$10 per installment payment to a maximum of \$40 per academic year.

**6. LATE FEE**

Late fee means a payment required of a licensee who fails to pay any fee when due (Title 5, Section 42000 (j)).

\$10 ↔ \$50 per late payment.

**7. CHECK RETURNED FEE**

\$10 is to be charged for all checks returned, regardless of the cause.
