I am transmitting to you a copy of Executive Order No. 562 which authorizes the establishment of the revised Student Body Association Fee Schedule for California State University, Bakersfield. The fee increase is being implemented based on the intent of the favorable election conducted by the Associated Students and on the material submitted with your August 7, 1990 request.

The student referendum approving an increase in the Student Body Association Fee discussed use of the funds to support child care. Use of the Associated Students fund for child care is permitted by Title 5, California Code of Regulations, Section 42659. The revenue from this fee, however, may be used for any purpose approved by the Trustees and is subject to regular allocation and appropriation procedures applicable to the Student Body Association.

The fee increase approved by the students called for implementation effective fall 1990, but due to the current timeframe, the collection of an increased fee cannot be accommodated for the fall quarter. I have therefore adjusted the 1991 winter and spring quarters fee level to provide for the collection of the \$2.00 increase scheduled for fall 1990.

In accordance with The California State University policy, the campus President has the responsibility for implementing Executive Orders where applicable and for maintaining the campus repository and index for all Executive Orders.

**Title:** Student Body Association Fee  
California State University, Bakersfield

**Effective Date:** August 29, 1990

**Supersedes:** Executive Order No. 513

Effective with the commencement of the Fall Quarter, 1990, the Student Body Association Fee Schedule requested by CSU, Bakersfield is approved for implementation. Student Body organization fees shall be collected in the amounts specified in this Order, except as waived in individual cases, pursuant to Education Code Section 89300. This action is taken pursuant to Chapter III, Section 6, subdivision "c" of the Standing Orders of the Board of Trustees.

The approved schedule is as follows:
