**Title:** Student Body Center Fee Schedule  
California State University, Sacramento

**Effective Date:** February 21, 1992

**Supersedes:** Executive Order No. 534

Effective Summer Session 1992, the revised Student Body Center Fee Schedule requested by California State University, Sacramento is approved for implementation. The fee schedule authorized herein shall supersede all such fees previously authorized for California State University, Sacramento. This action is taken pursuant to Chapter III, Section 6, Subdivision "d" of the Standing Orders of the Board of Trustees.

The student body center fees shall be charged as herein authorized, pursuant to Education Code Section 90012, subdivision (c) and Education Code Section 90068.
