**Subject:** Student Body Association Fee, California State University, San Marcos,  
Executive Order No. 604

I am transmitting to you a copy of Executive Order No. 604 which authorizes the establishment of the revised Student Body Association Fee at California State University, San Marcos.

The student referendum approving an increase in the Student Body Association Fee also discussed use of the funds to establish a building reserve fund for construction of a new child care center and interim child care program. Use of the Associated Students' funds for these purposes is permitted by Title 5, California Code of Regulations, Section 42659(o). The revenues from this fee, however, may be used for any purpose approved by the Trustees and are subject to regular allocation and appropriation procedures applicable to the Student Body Association.

In accordance with policy of The California State University, the campus president has the responsibility for implementing Executive Orders where applicable and for maintaining the campus repository and index for all Executive Orders.

**Title:** Student Body Association Fee  
California State University, San Marcos  
**Effective Date:** July 16, 1993  
**Supersedes:** Executive Order No. 580

Effective with the Fall Semester 1993, the Student Body Association Fee Schedule requested by California State University, San Marcos, is approved for implementation. Student Body Association fees shall be collected in the amounts specified in this Order, except as waived in individual cases, pursuant to Education Code, Section 89300. This action is taken pursuant to Chapter III, Section 6, subdivision "c" of the Standing Orders of the Board of Trustees.


