Subject: Student Body Association Fee – California State University, Sacramento
Executive Order No. 624

I am transmitting a copy of Executive Order No. 624 which authorizes the establishment of the revised Student Body Association Fee Schedule for California State University, Sacramento.

The fee referendums approved by the students on April 26 and 27, 1994, proposed funding for a Regional Transit Contract for CSU student transportation and for funding of grant programs, respectively. Use of student body organization funds for these purposes is permitted by Title 5, California Code of Regulations, Section 42659. However, the revenue may be used for any purpose approved by the Trustees and is subject to regular allocation and appropriation procedures applicable to the student body association.

The fee referendum approved by the students for transportation services specified a temporary fee increase of \$2.00 through Spring Semester 1996, while the second fee referendum specified a permanent fee increase of \$5.00 for grant programs.

In accordance with policy of The California State University, the campus President has the responsibility for implementing Executive Orders where applicable and for maintaining the campus repository and index for all Executive Orders.

Executive Order No. : 624

Title: Student Body Association Fee – California State University, Sacramento

Effective Date: June 20, 1994

Supersedes: Executive Order No. 620

Effective with the Fall Semester 1994, the Student Body Association Fee Schedule requested by California State University, Sacramento is approved for implementation. The fee schedule authorized herein shall supersede all such fees previously authorized for California State University, Sacramento. Student Body Association fees shall be collected in the amounts specified in this Order, except as waived in individual cases, pursuant to Education Code Section 89300. This action is taken pursuant to Chapter III, Section 6, subdivision "c" of the Standing Orders of the Board of Trustees.
