


Title: Miscellaneous Course Fees for section numbers: CDES 132, CDES 152, CM 195, CSCI 010, GEOG 001, MFGT 147, MUS 101, NFSC 126L, and MFGT 243, California State University, Chico

This Executive Order is issued pursuant to authority granted by Education Code Section 89700, Standing Orders of the Board of Trustees, Chapter III, Section 6-f-1, and Board of Trustees' Resolution RFIN 05-96-06 and consonant with Executive Order No. 661.

Effective spring 2000, California State University, Chico is authorized to establish the following optional miscellaneous course fees at the amounts requested: CDES 132, inks and paper, \$8; CDES 152, various audio-visual supplies, diskettes, photocopies, paper, printing supplies, \$25; CM 195, inks and paper, \$10; CSCI 010, monitor computer lab, paper and printer supplies, \$15; GEOG 001, computer printouts, field trips, \$5; MFGT 147, composite materials and processing projects, \$10; MUS 101, computer and audio supplies, paper, music scores, \$20; NFSC 126L, nutrition assessment supplies, \$15; and MFGT 243, polymer and tooling projects, \$10. Revenue from these optional miscellaneous course fees may be deposited in a local trust account pursuant to Education Code Section 89721(g) and must be used solely to meet the costs of providing the service.
