Subject: Executive Order No. 739: Optional California State University Summer Term Per Unit Fee Schedule.

I am transmitting to you a copy of Executive Order No. 739, which gives California State University campuses the option to establish a summer term per unit fee schedule. Use of the summer term per unit fee schedule is not mandated by the system.

Each campus adopting the summer term per unit fee schedule must estimate its revenue expectation for a summer term and, therefore, maintain responsibility for meeting its revenue goal without additional support from the CSU systemwide office.

The summer term per unit fee schedule will be re-evaluated as summer programs are implemented and expanded or as any changes to the State University Fee occur through Board approval processes.

In accordance with policy of the California State University, the campus president has responsibility for implementing Executive Orders where applicable and for maintaining the campus repository and index for all Executive Orders.

Title: Optional Summer Term Per Unit Fee Schedule


Effective Date: Summer Term 2000

Supersedes: No Previous Executive Order

This Executive Order is issued pursuant to authority granted by Education Code Section 89700 and Board of Trustees' Resolution RFIN 07-99-08. Effective summer term 2000, California State University campuses are authorized to establish the following optional summer term per unit fee schedule.

Fees paid by a student in a given summer term based on the optional per unit fee rate may not exceed the maximum semester/quarter fee rates established by the California State University Board of Trustees. The summer term per unit fee is optional and is not mandated by the system. Summer term per unit fees must be deposited in the General Fund and be used for the support of the University pursuant to Education Code Section 89724(a).
