

Subject: Executive Order No. 748 authorizing California State University, Chico to establish Miscellaneous Course Fees for Course Numbers CDES 92, CDES 234, CDES 292, ME 025, MFGT 124, MFGT 242, MFGT 243, MFGT 280, ART 058

I am transmitting to you a copy of Executive Order No. 748, which authorizes California State University, Chico to establish Category III Miscellaneous Course Fees for course numbers CDES 92, CDES 234, CDES 292, ME 025, MFGT 124, MFGT 242, MFGT 243, MFGT 280, ART 058.

In accordance with the fee policy of the California State University, each campus is required to report to the chancellor for the most recently completed fiscal year a complete inventory of all fee levels charged to students and the total revenue collected for each fee. With regard to reporting of miscellaneous course fees, overall campus miscellaneous course fees levels charged and combined total revenue should be reported jointly in the annual fee report.

Further, the campus president has the responsibility for implementing executive orders where applicable and for maintaining the campus repository and index for all executive orders.

This Executive Order is issued pursuant to authority granted by Education Code Section 89700, Standing Orders of the Board of Trustees, Chapter III, Section 6-f-1, and Board of Trustees' Resolution RFIN 03-04-00, and consonant with Executive Order Number 740.

Effective fall term 2000, California State University, Chico is authorized to establish miscellaneous course fees for the following courses at the fee rates indicated:

CDES 92, Introduction to Photo & Digital Imaging, \$10
CDES 234, Kinetic Typography, \$20
CDES 292, Appl. Photo & Digital Imaging, \$25
ME 025, Engineering Graphics, \$3
MFGT 124, Computer Graphics, \$3
MFGT 242, Polymer Flow Analysis, \$3
MFGT 243, Polymer Design & Tooling, \$10
MFGT 280, Project Management, \$3
ART 058, Introduction to Computer Art, \$25

The above miscellaneous course fees are required of those persons who, at their option, use the services and materials provided for which the fees are charged. Pursuant to section 89721(g) of the Education Code, monies collected from this fee may be deposited in local trust accounts and must be used solely to meet the costs of providing the services and materials.
