Title: Fingerprinting Service Fee, Fingerprinting Processing Fee, Printing Fee, and Miscellaneous Course Fees for Biology 25, Biology 26, Art 137, Art 197, and Art 198

Effective Date: Fall term 2000



This Executive Order is issued pursuant to authority granted by Education Code Section 89700, Standing Orders of the Board of Trustees, Chapter III, Section 6-f-1, and Board of Trustees' Resolution RFIN 03-04-00, and consonant with Executive Order Number 740.

Effective fall term 2000, California State University, Sacramento is authorized to establish the following Category III fees at the fee rates indicated:

Fingerprinting Service Fee, \$10
Fingerprinting Processing Fee, fee range between \$15 and \$260
Printing Fee, \$.05 per copy
Biology 25, \$3
Biology 26, \$7
Art 137, \$13
Art 197, \$17
Art 198, \$17

Pursuant to section 89721(g) of the Education Code, revenue collected from the Fingerprinting Service Fee, Fingerprinting Processing Fee, and Printing Fee may be deposited in local trust accounts and must be used solely to meet the costs of providing the services and materials. Revenue collected from miscellaneous course fees for Biology 25, Biology 26, Art 137, Art 197 and Art 198 must be deposited in the General Fund of the State Treasury and is appropriated for the support of the University pursuant to Education Code Section 89724(a).
