

Executive Order: 818

Title: Advanced Practice Nursing Evaluation Fee, and Distance Learning Fee for Online Degree Programs; California State University, Fullerton


Effective Date: May 16, 2002

Supersedes: No Prior Executive Order

This Executive Order is issued under the authority granted by Education Code Sections 89035, 89700, Standing Orders of the Board of Trustees, Chapter III, Sections 1, 2 and 6-f-1, and Board of Trustees' Resolution RFIN 03-04-00, and consonant with Executive Order No. 740.

Effective May 16, 2002, California State University, Fullerton is authorized to establish a Category III, Advanced Practice Nursing Evaluation Fee, and a Category III Distance Learning Fee for Online Degree Programs. The Advanced Practice Nursing Evaluation Fee will cover costs that include administration of clinical evaluations and national examinations and orientation sessions for preceptors. The Advanced Practice Nursing Evaluation Fee is established at a fee rate of \$500. The Distance Learning Fee for Online Degree Programs will supplement additional administrative and operational costs associated with facilitating related technology. The Distance Learning Fee for Online Degree Programs is established at a fee rate of \$75.

Revenue collected from the Advanced Practice Nursing Evaluation Fee and the Distance Learning Fee for Online Degree Programs shall be deposited in the State Treasury and credited to the General Fund as required by Section 89724(a).
