This Executive Order is issued under the authority granted by Education Code Sections 89035, 89700, Standing Orders of the Board of Trustees, Chapter III, Sections 1, 2 and 6-f-1, and Board of Trustees' Resolution RFIN 03-04-00, and consonant with Executive Order Number 740.

Effective July 8, 2002, San Diego State University is authorized to establish a Category III, Summer Florence Semester Course Fee. This fee will cover the cost of housing, food, field trips, activities, and insurance. The Summer Florence Semester Course Fee is established at a fee range of \$4,075 to \$5,000.

Revenue collected from course fees are to be deposited either in the General Fund or in a local trust account, depending on the nature of the fee. As required by Education Code Section 89721(g), revenue collected may be deposited in a local trust account where the fee is required of those persons who, at their option, use the services or facilities, or are provided the materials, for which the fee is collected. In other words, if the student has the option to procure services for which the fee is charged on the open market or some other way separate from the university and still fulfill the requirements of the university course, the revenue may be deposited in trust. Fees so deposited shall be used solely to meet the costs of providing these services. Otherwise, as required by Section 89724(a) of the Education Code, revenue collected from course fees shall be deposited in the State Treasury and credited to the General Fund for the support of the university in addition to such other amounts as may be appropriated by the Legislature.
