Subject: 2009-10 State University Fee Increase

As you are probably aware, the State of California is in a severe financial crisis. The CSU faces a \$584 million budget cut, the largest in the system's history. The reduction is the result of the state's attempt to close a \$26.3 billion budget gap. Chancellor Charles B. Reed has said, "We have never before seen such a devastating cut in a single year. I am concerned because the CSU system has a national reputation for access, quality and diversity."

At its meeting held on July 21, 2009, the CSU Board of Trustees approved a 2009-10 State University Fee (SUF) increase of 20%. This means that the State University Fee will increase for all CSU students effective fall term 2009. Please refer to the attachment "2009-10 State University Fee and Non Resident Fee Tuition Increase Summary" for the specific amounts of the new SUF for undergraduates, credential, graduate and nonresident students. Please review the form, choose a payment option and return the form to us with your signature.

We recognize that this added cost will be a financial challenge for you. The Office of International Programs will work with you in coming up with a payment plan for the additional cost. For those of you who are on financial aid, please contact your campus financial aid office to see if additional funds may be awarded to cover the increase.
