- More than 50% of undergraduates leave with no loan debt





Fall 2023 Transfer Minimum Eligibility

- Upper Division Transfer
 - 60 units of transferrable coursework
 - Overall college GPA of at least a 2.00
 - Be in good standing at the last college attended
 - Complete General Education/Golden Four

- 16 universities have no impaction or program impaction only
- Discontinued impaction: Fresno, Northridge, Sacramento, San Bernardino, San Marcos, & Sonoma





Key Dates

- October 1: Fall 2024 Application Opens at 6 a.m.
 - Up to Four Fee Waivers
- November 30: Priority Application Deadline for impacted campuses





Assembly Bill 928

- Single GE pattern for CSU and UC transfer admissions
- No more IGETC or CSU GE Breadth at community colleges as of fall 2025
- Community College students will be placed on an Associate Degree for Transfer (ADT) path if available

- Agreement with one CSU campus required









FAFSA Simplification 2024-25

- FAFSA will not be available until December 2023
 - More streamlined application process tax filers
- Student Aid Index (SAI) replaces Expected Family Contribution (EFC)
- Contributor(s) anyone who needs to provide information on the FAFSA
- FAFSA will rely on family's tax return information
- Students can no longer complete parent section
- Increased aid for single parents
- Priority filing deadline extended to April 2, 2024
