The request should also identify the agenda item the speaker wishes to address. Efforts will be made to accommodate each individual who has requested to speak.

Members of the public may also address the full IAC on any non-agendized topic that is related to CSU Investments. The purpose of public comments is to provide information to the IAC, and not to evoke an exchange with IAC members. Questions that IAC members may have resulting from public comments will be referred to appropriate staff for response.

In fairness to all speakers who wish to speak, and to allow the IAC to hear from as many speakers as possible, while at the same time conducting the public business of their meetings within the time available, public comment will be limited to no more than 2 minutes per speaker, or less depending on the total number of speakers requesting comment per meeting. Ceding, pooling, or yielding remaining time to other speakers is not permitted. Speakers are requested to make the best use of the public comment opportunity and to follow the rules established.
