Subject:

2015/16 Centrally Paid Dental Annuitant Indirect Costs

Beginning with the 2015/16 fiscal year, the Chancellor's office will allocate Dental Annuitant costs to CSU Auxiliary Enterprises. The purpose of this memorandum is to provide a summary of the total costs that will be charged to your campus during the 15/16 fiscal year.

Campuses will be charged approximately \$1,066,000, which will be assessed in four quarterly installments of \$266,500 and billed on or about October 28th, January 15th, April 15th, and June 30th. Each campus' portion of the quarterly assessment can be found on the attached summary as well as attachments by program.

Dental Annuitant costs will utilize similar methodology as the Department of Finance State Pro Rata charges. Campuses' employee retirement costs (FIRMS object code 603005) from the previous two fiscal years will be used as the cost driver to determine the prorated share of the actual dental annuitant costs. All billable special revenue CSU funds reporting employer-paid retirement expenditures will be included for the allocation. A deviation from the State Pro Rata method, is that exact costs are not known to the Chancellor's Office in advance; therefore, distribution will be done quarterly on an actual basis as expenses are incurred.
