# Key Issues

# AB 1460 Implementation

Since our September 2020 plenary, and in accordance with AB 1460, the ASCSU Executive Committee has met for an hour on October 14, 2020 and October 21, 2020 with CSU Council on Ethnic Studies (CSUCES) and Chancellor's Office for formal consultation on the Core Competencies for the CSU Ethnic Studies Requirement. The minutes from the October 14, 2020 meeting have been shared and those from the October 21, 2020 meeting are forthcoming. Please share these with your campus constituents.

As liaison from the Executive Committee to the CSU Council on Ethnic Studies, I continue to maintain regular communication with CSUCES Chair Monteiro. Central in these conversations are strategies for ensure effective communication between the ASCSU and the CSUCES, their rationale for requesting a graduation requirement rather than a G.E. requirement and advising needs of students in Ethnic Studies post-implementation. It is my sincere hope that communication will continue throughout the year and supplement the communications that occur between the Academic Affairs and the CSUCES to ensure disciplinary perspectives inform ASCSU efforts.

In a similar vein, I have maintained regular communication with Executive Vice Chancellor Blanchard and Assistant Vice Chancellor Van Cleve on similarities and differences between Executive Order implementation under the Chancellor's Office (CO) recommendation to the Board of Trustees (BoT) and AB 1460. In a similar vein, regular communication has been maintained with campuses through their campus senate chairs and/or task forces on Ethnic Studies to ensure robust faculty input on the CSU Ethnic Studies Requirement draft policy through Town Halls and meetings. These have occurred independently and in collaboration with Associate Vice Chancellor Wrynn and Assistant Vice Chancellor Van Cleve. Central in these discussions have been the importance of explaining the similarities and differences between ASCSU and CO purviews, work on core competencies, and timeline going forward. These discussions have also included the Chancellor's Office explanations of their purview and rationales behind the draft policy.

The ASCSU Executive Committee will continue to map strategies for consultation on the implementation of AB 1460 and consult with Executive Vice Chancellor Blanchard and

Assistant Vice Chancellor Van Cleve. These consultations continue to engage the way in which the ASCSU is taking an active role in faculty consultation on curricular impacts caused by the implementation of AB 1460, best practices needed to ensure successful implementation and minimize campus curricular disruption, and ensure that campuses are able to implement the requirement according to their respective aims, missions, and values.

### Ad Hoc Committee on Equity, Diversity, and Inclusion (AEDI)

The ASCSU Executive Committee has appointed At-Large Senator Nola Butler-Byrd as AEDI liaison. Senator Mark Martinez (Bakersfield) and Senator Adam Swenson (Northridge) have been appointed to serve on AEDI for 2020-2021. Senators Martinez and Swenson will replace Senators Bezdecny and Waltz.

#### Ad Hoc Committee on Open Access

The call for ASCSU representation on the Ad Hoc Committee on Open Access is out and all interested senators are encouraged to submit a statement of interest. Chair Collins and Vice Chair Yee-Melichar will serve on the committee until appointments are made.

## Intersegmental Committee of Academic Senates (ICAS)

On October 13, 2020, the chair of ICAS rotated from the California Community College (CCC) and President to the ASCSU, and I had the honor of convening the October meeting. This joint meeting of the Academic Senate leadership from the three segments (i.e., California Community Colleges (CCC), California State University (CSU), and University of California (U.C.)) of public higher education in the State of California engaged in conversations that included but were not limited to the following:

CSU: Intersegmental collaborations related to how to further reduce barriers to student transfer, mental health and faculty and student success during the COVID-19 Pandemic, and formerly incarcerated student success.

U.C.: Senate's Principles: Working with Incarcerated or Formerly Incarcerated Students. Central in this discussion was the potential for ICAS endorsement and transfer pathways for incarcerated students. Academic integrity concerns related to Chegg and Course Hero were also discussed.

CCC: Articulation and CCC Course Outlines and Faculty Discipline Review Groups (FDRG) Requirements for Course Identification Numbering System (C-ID). Central in these discussions was the need for greater CSU faculty participation in the process and how to enable more effective communication between the segments on transfer.

ICAS also discussed Legislative Day Planning. Central in this discussion was the importance of targeted invitations to legislators and stressing common talking points that can lend to full funding of all three systems, support for intersegmental meetings for

discussions of transfers, and resources for faculty professional development and student supports during the COVID-19 Pandemic.
