**REQUIREMENTS FOR FACULTY DISCIPLINE REVIEW GROUP MEMBERSHIP
IN SUPPORT OF THE DEVELOPMENT AND OVERSIGHT OF TRANSFER
MODEL CURRICULA**

RESOLVED: That the Academic Senate of the California State University (ASCSU) endorse the following requirements for Faculty Discipline Review Group (FDRG) membership in the SB 1440 Transfer Model Curriculum (TMC) and Model Curriculum (MC) development and review process:

- i. FDRG members shall be appointed from the ranks of CSU faculty with broad experience in curriculum/articulation and expertise in the discipline of the potential Transfer Model Curricula and Model Curricula.
- ii. The majority of the CSU faculty appointed to a FDRG shall be tenured.

; and be it further;

RESOLVED: The Academic Senate of the CSU (ASCSU) endorse the following guiding principles:

- i. The ASCSU committee shall appoint faculty to the FDRG;
- ii. The term of service as a member of the FDRG shall be 3 years, renewable. If the faculty member should retire before the end of their term, they may remain on the FDRG until either the completion of their term or the appointment of a successor;
- iii. That an FDRG for the largest 20 transfer majors include at least 3 CSU FDRG members but that the FDRGs for other TMCs may have fewer members (but never less than the number of CCC FDRG members);
- iv. The ASCSU executive committee shall ensure that FDRGs are fully staffed with CSU faculty members and shall replace members as appropriate.

; and be it further,

RESOLVED: That the ASCSU distribute this resolution to C-ID leadership, Intersegmental Curriculum Workgroup Membership, Academic Senate CCC, California Intersegmental Articulation Council listserv, Intersegmental Council of Academic Senates membership, Executive Vice Chancellor Loren Blanchard

RATIONALE: *This resolution follows an earlier resolution (AS-3346-18/APEP/AA) that described the requirements for a CSU faculty member to be appointed as a Course Outline of Record Evaluator (CORE) reviewer to the C-ID*

process. This resolution addresses the qualifications to be appointed as a member of the Faculty Discipline Review Group (FDRG) as well as expectations regarding the term of service. This resolution is timely in that many of the original FDRG members for the original 20 disciplines are no longer active as the next five-year review cycle is beginning.

As the development of ADTs extends further to encompass majors with smaller numbers of transfer students, this resolution acknowledges the request of the CCC Academic Senate (ICAS, October 2018) to permit the development of some FDRGs with fewer faculty members. The 40 now extant ADTs encompass more than 90% of the preferred majors of students transferring from the CCC to the CSU (CSU Board of Trustees, Committee on Educational Policy, January 2019). This resolution also reinforces the long-standing practice that holds the CCC and CSU to be equal partners in the development and oversight of ADTs.

The inclusion of commentary related to the duration of service on the FDRG answers questions about how long a member is anticipated to serve and supports the goal of allowing membership to carry-over across review cycles [ADT typically use a five-year review cycle]).
