

**EXECUTIVE SUMMARY OF RESOLUTIONS  
ACADEMIC SENATE CSU PLENARY – MAY 18-19, 2017**

The Academic Senate CSU (ASCSU) met at the Chancellor's Office in Long Beach on March 18-19, 2017 and approved the following resolutions. All can be accessed at the [ASCSU website](#).

**AS-3283-17/FA (Rev) - Establishment of a Task Force to Explore Models of Employment Security for Senior Contingent Faculty, Librarians, Coaches, and Counselors**

***Approved Unanimously***

The ASCSU urges the California State University (CSU) system, in conjunction with the ASCSU and the California Faculty Association (CFA), to establish a group tasked to investigate models of employment that would provide greater employment security for contingent faculty, librarians, coaches and counselors.

**AS-3291-17/APEP (Rev) - Incorporating Quantitative Reasoning Task Force (QRTEF) Recommendations in Revising Executive Order (EO) 1100**

***Postponed Indefinitely (Unanimous)***

The ASCSU supports the revision of Executive Order 1100 and associated documents (e.g., CSU Guiding Notes) in order to incorporate recommendations concerning quantitative reasoning / mathematics competency outlined in the Quantitative Reasoning Task Force report.

During the course of Senate discussion, however, it became clear that questions regarding the resolution language [originally introduced as AS-3291-17/APEP remained unresolved and that further deliberation in committee was required. Consideration of the item was postponed to allow time for this to occur.

**AS-3292-17/EX (Rev) - Academic Senate of the CSU Calendar of 2017-2018 Meetings**

***Approved Unanimously***

The ASCSU approves the calendar of meetings for 2017-2018.

**AS-3293-17/AA (Rev) - Support for Active Learning and High Impact Practices in CSU Graduation Initiative 2025**

***Approved Without Dissent***

The ASCSU reaffirms its commitment to “active learning” practices as adopted in the Access to Excellence strategic plan, and urges the CSU to make known its commitment to these practices in explicit ways as part of the Graduation Initiative 2025. The ASCSU emphasizes that in doing so:

- funding and actions should be directed to instructional faculty and staff;
- a portion of the Graduation Initiative 2025 funding should be used for professional development and implementation of high impact practices;
- the ASCSU and CSU should highlight the connection between improved graduation and retention rates, active learning and high impact practices, and the public good.

**AS-3295-17/FGA/ (Rev) - Campus Accommodation of Military Students’ Service Obligations**

***Approved Unanimously***

The ASCSU urges campus faculty to make appropriate accommodations for students with military service obligations, and urges campus senates and administrations to consider adopting academic practices to facilitate successful course completion by such students.

**AS-3296-17/FA - Regarding Lack of Consultation on the Drafting of a CSU Intellectual Property Policy**

***Approved Without Dissent***

The ASCSU affirms that faculty were not consulted during the drafting of the CSU Intellectual Property (IP) policy and maintains that an invitation to respond only after the fact to the fully formulated policy does not represent either “shared governance” or shared decision-making.”

The ASCSU further holds that because the policy as now drafted deals primarily with terms and conditions of employment, faculty interests in these areas are best represented through collective bargaining. Given the short timeline allowed for comment on the policy draft the ASCSU does not proffer one, however the ASCSU asserts that campus senates have the right to weigh in on policy drafts independently and not only through the Academic Senate.

**AS-3297-17/EX - Expression of Respect for CSU San Bernardino (CSUSB) No-Confidence Vote in President Tomás Morales**

***Approved Unanimously***

The ASCSU expresses its respect for the thoughtful process engaged in by the CSU San Bernardino Faculty Senate leading up to its resolution of no confidence in President Tomás Morales, and the principled decision to send the matter to a referendum of the full faculty.

Additionally, the ASCSU expresses its concern over the seeming lack of recognition in Chancellor White's response of the serious issues raised by the CSUSB no-confidence vote.

The ASCSU urges the Board of Trustees develop a policy for guiding their and the chancellor's responses to votes of no confidence in presidents by campus faculty and, in the absence of such a policy, follow the steps recommended in AS-3075-12 to investigate the issues raised in the CSUSB vote of no confidence resolution.

**AS-3298-17/EX - Violation of Confidentiality of CS San Bernardino (CSUSB)  
Presidential Search Process and Censure of Trustee Emeritus Lou Monville and Mr.  
Paul Granillo**

*Approved*

The ASCSU expresses its grave concern over the violation of confidentiality of the CSUSB presidential search process by Trustee Emeritus and former Chair of the CSU Board of Trustees Lou Monville, and community member Paul Granillo in a May 8, 2017 op-ed about the CSUSB Academic Senate and its vote of no confidence in President Tomás Morales. In doing so, the ASCSU endorses ASCSU Chair Christine Miller's May 9, 2017 letter to the CSUSB Faculty Senate in response. Additionally, ASCSU censures Trustee Emeritus Monville and Mr. Granillo for violating the confidentiality of the presidential search process and revokes its May, 2016 commendation in Honor of Trustee Emeritus Lou Monville.

Finally, the ASCSU calls upon the Board of Trustees to rescind the honorary doctorate scheduled to be conferred upon Trustee Emeritus Monville and urges the Board to refrain from appointing Trustee Emeritus Monville and Mr. Granillo to CSU search committees in the future.
