Executive Order: 870

Title: Miscellaneous Course Fee for Geological Sciences Section GEOL
450-Summer Field Geology; California State University, Long Beach


Effective Date: June 25, 2003

Supersedes: No Prior Executive Order

This executive order is issued under the authority granted by Education Code Sections 89035, 89700, Standing Orders of the Board of Trustees, Chapter III, Sections 1, 2 and 6-f-1, and Board of Trustees' Resolution RFIN 03-04-00, and consonant with Executive Order No. 740.

Effective June 25, 2003, California State University, Long Beach is authorized to establish a Category III, Miscellaneous Course Fee for Geological Sciences Section GEOL 450-Summer Field Geology. The fee will cover costs of dormitory and motel lodging and food. The Summer Field Geology course fee is established at a fee range of \$1,118 to \$1,381.

Pursuant to Sections 90002 and 90074 of the Education Code, revenues collected from fees for state university lodging and services supported by the campus housing program shall be deposited in the California State University Dormitory Revenue Fund. Revenues collected from miscellaneous course fees for lodging and services not supported by the campus housing program are to be deposited either in the General Fund or in a local trust account, depending on the nature of the fee. In accordance with Education Code Section 89721(g), revenue collected may be deposited in a local trust account where the fee is required of those persons who, at their option, use the services or facilities, or are provided the materials, for which the fee is collected. In other words, if the student has the option to procure the service or materials for which the fee is charged on the open market or some other way separate from the university and still fulfill the requirements of the university, the revenue may be deposited in trust. Revenue so deposited shall be used solely to meet the costs of providing these services, materials, and facilities. Otherwise, in accordance with Section 89724(a) of the Education Code, revenue collected from miscellaneous course fees shall be deposited in the State Treasury and credited to the General Fund for the support of the university in addition to such other amounts as may be appropriated therefor by the Legislature.
