Executive Order: 871

Title: Supplemental Fees for Off-Campus Programs; California State University, Northridge

Effective Date: June 25, 2003


Supersedes: Executive Order No. 830

This executive order is issued under the authority granted by Education Code Sections 89035, 89708, Standing Orders of the Board of Trustees, Chapter III, Sections 1, 2 and 6-f-1, and Board of Trustees' Resolution RFIN 03-04-00, and consonant with Executive Order No. 740.

Effective June 25, 2003, California State University, Northridge is authorized to establish Category III, Supplemental Fees for Off-Campus Programs. The fees will cover costs associated with off-campus state supported degree programs and include the cost of program marketing, faculty travel, space rental, mode of delivery, library support, on-site student services, and academic support. The supplemental fee level for off-campus courses taught in person by instructors will range from \$105 to \$155 per unit. The supplemental fee level for off-campus courses transmitted to remote sites by on-line, televised or other mixed mode of delivery will range from \$160 to \$265 per unit.

These fees may only be charged to off-campus students and may not be charged to students on the main campus or to students of formally approved off-campus centers. If the CSU should adopt systemwide policy for funding state-supported off-campus instruction that conflicts with this executive order, it may be reviewed and rescinded.

Revenue collected from Supplemental Fees for Off Campus Programs shall be deposited in the State Treasury and credited to the General Fund for the support of the university in addition to such other amounts as may be appropriated therefor by the Legislature in accordance with Education Code Section 89724(a).
