California State University Report: Utilization of Facilities Student Space (Classrooms and Teaching Labs)

The California State University's (CSU) Utilization of Facilities report is submitted based on the fall 2022 enrollment data and reflects the system's continued emergence from the COVID-19 pandemic. The Education Code, Section 67503, requires the Utilization of Facilities report to be submitted biennially to report on the use of classrooms and laboratories.

CSU is assessing the continued use of the Academic Planning Database to track and report on student enrollment per discipline. We aim to confer with our Division of Academic and Student Affairs next year to identify how the transition to remote instruction and hybrid instruction may have resulted in faulty or incomplete data. Given the age of the Academic Planning Database program, it is timely to revisit alternatives to provide the systemwide academic reporting.

Fall 2022 Classroom and Teaching Laboratory Utilization Report California State University

Executive Summary of the Space Utilization Report

Due to the continuation of the global Covid-19 pandemic, the data for these reports was impacted. The traditional methods for teaching classes were disrupted as all CSU universities were forced to adjust to alternate methods of delivering classes during the pandemic. Reporting methods of hybrid instruction caused anomalies in utilization reporting and impacted university utilization percentages.

The Classroom and Teaching Laboratory Utilization is generated for each of the 23 universities of the California State University system. Capacity space in the CSU is categorized as lecture or teaching laboratory to serve the Full-Time Equivalent (FTE) student enrollment. The reports are used to show how efficient the CSU is using capacity space based on California's higher education space standards set by the state legislature. Instructional space needs are calculated in conformity with Space and Utilization Standards approved in September 1966 by the Coordinating Council for Higher Education (re-titled the California Postsecondary Education Commission prior to dissolution) as modified by the Legislature in March 1971 and June 1973. It is based on the hours per week a classroom or laboratory space is scheduled and the student station occupancy per class.

Main points of the Classroom and Teaching Laboratory Utilization Reports:

- Report to the Legislative Analyst's Office (LAO) biennially
- Compare the utilization of classrooms and teaching laboratories for the fall term to the legislatively approved standards and to use 24 hours per day, 7 days per week (24/7)
- Utilization Reports are used as a planning tool

1. Introduction

This is a report of the utilization of instructional space throughout the California State University. The purpose of this report is to compare the utilization of classrooms and teaching laboratories for the fall 2022 term to established standards to inform capital outlay planners about the needs for space and to inform the universities about their use of space.

2. Methodology

Utilization is measured by determining the average number of hours per week that the stations in a given category of space are used by scheduled course sections, whether or not the course sections are of the same type of instruction as the room itself. That is, a lecture course taught in a laboratory space adds to the average use of laboratory stations, despite the fact that the course is not a laboratory course. Courses that are taught by individual supervision do not regularly meet in a classroom or a class laboratory and, thus, do not contribute to the hours of use of a room. Enrollments in these courses do not enter into the calculation of the equivalent weekly station hours (WSH) or weekly student contact hours (WSCH) for this report, as it focuses only on lecture and laboratory FTE.

The produced utilization reports are summaries of the average weekly usage by size of room. Current legislative standards are based on classroom use on the hours between 8 A.M. and 10 P.M. and teaching laboratory use on the hours between 8 A.M. and 5 P.M., Monday through Friday. Section 3 will further explain the factors and formulas that generate utilization standards.

The methodology in the CSU utilization reports were initially modified in 2002 to expand the time of classroom and teaching laboratory use to between 5 A.M. and 10 P.M., Monday through Saturday, and since 2012 the report provides a comparison using the 24/7 period. Although there is only a slight difference in classroom utilization, teaching laboratory utilization percentage increased significantly under the modified days and hours of use compared to the standards. This report includes all campuses physical capacity for classroom and teaching laboratory, whether or not course sections were scheduled in those rooms. This methodology provides a more accurate view of how universities utilize the entire physical capacity funded through the Capital Outlay Program.

3. Utilization Standards for Instructional Space

Utilization standards for classrooms and teaching laboratories in public higher education are set by the state legislature. These standards divide instructional space into three categories: lecture, lower-division teaching laboratory, and upper-division teaching laboratory. Teaching laboratories on the graduate-division level are held to the same utilization requirements as upper-division laboratories.

The normative standards for classrooms and teaching laboratories are derived from two factors:

- (1) the average hours per week a room (and thus a station) is expected to be scheduled, and
- (2) the percent of student stations expected to be occupied when the room is scheduled.

The product of these factors yields the average number of hours per week a station is expected to be occupied. For this report, the standards were applied to rooms grouped by space type (lecture or lab), then by station count, not individual rooms.

Through ACR 151 (enacted in 1970), the legislature set the current standards for lecture room utilization. The average lecture room is to be scheduled 75% of the hours from 8 A.M. to 10 P.M., Monday through Friday (70 hours) for a total of 53 scheduled hours per week. When scheduled, the lecture room is to have, on the average, 66% of the stations filled.

In 1973 budget language, the legislature set laboratory standards. Lower-division laboratories are to be scheduled an average of 27.5 hours per week and filled to 85% of capacity, yielding a standard 23.4 station hours per week.

For upper-division and graduate-division laboratories, each room is to be scheduled, on the average, for 22 hours per week at 80% occupancy, yielding a standard of 17.6 station hours per week:

Thus, a university is not fully utilizing its instructional space until its lecture stations are in use 35 hours per week; its lower-division laboratory stations are in use 23.4 hours per week; and, its upper- and graduate-division laboratory stations are in use 17.6 hours per week. It should be noted that the laboratory standards are based on a 45-hour week, that is, 8 A.M. to 5 P.M., Monday through Friday.

Because teaching laboratory instruction may serve each level of the student population in a given week, or even simultaneously, depending on class enrollment and scheduling, for purposes of this report, the average of the two standards, lower-division and upper-division as shown above, results in 20 hours per week expected utilization. This corresponds with the LAO report “Higher Education: Flexible Facility Utilization Standards” concept to “establish a single standard for teaching laboratories (without regard to upper- or lower-division distinction) of 20 hours of station use per week.”

Utilization Standards are expressed in terms of Weekly Room Hours (WRH) and Weekly Station Hours (WSH). The Weekly Room Hour (WRH) denotes the amount of time a room is scheduled each week in a term. The Weekly Station Hour (WSH) is based on the number of hours each room is scheduled and the number of seats in the room in a week. The Weekly Student Contact Hour (WSCH) calculation is based on the number of hours each room is scheduled and the number of students enrolled in the class in a week scheduled to be face-to-face with a faculty member in class from the Academic Planning Database.
