IN 1973 A HOME IN BEL AIR WAS DONATED FOR THIS PURPOSE (AT THE TIME, THE CSU OFFICE OF THE CHANCELLOR WAS LOCATED IN LOS ANGELES). SUBSEQUENTLY, THE OFFICE OF THE CHANCELLOR MOVED TO LONG BEACH AND, IN 1990, THE BEL AIR HOME WAS SOLD AND THE STATE UNIVERSITY HOUSE WAS PURCHASED IN LONG BEACH TO SERVE AS THE RESIDENCE OF THE CHANCELLOR. THE REMAINDER OF THE FUNDS AFTER THE PURCHASE WERE HELD IN TRUST FOR THE MAINTENANCE AND OPERATION OF THE STATE UNIVERSITY HOUSE. IN 2013, THE FUNDS HELD IN TRUST WERE TRANSFERRED TO THE CSU FOUNDATION FOR MORE EFFECTIVE INVESTMENT MANAGEMENT. THE CSU FOUNDATION PROVIDED AN ANNUAL DISTRIBUTION FROM THIS ENDOWMENT TO THE UNIVERSITY TO BE USED FOR OPERATING EXPENSES FOR THE STATE UNIVERSITY HOUSE. IN 2018, THE UNIVERSITY DETERMINED THAT IT WAS IN THE BEST INTEREST OF THE CSU TO SELL

IN FUTURE YEARS, THE FULL ANNUAL AMOUNT WILL BE TRANSFERRED FROM THE CSU FOUNDATION TO THE UNIVERSITY EACH JULY. THE GOAL OF THE CSU CONTINUES TO BE TO ATTRACT, MOTIVATE, AND RETAIN THE MOST HIGHLY QUALIFIED INDIVIDUALS TO SERVE AS FACULTY, STAFF, AND EXECUTIVES, WHOSE KNOWLEDGE, EXPERIENCE, AND CONTRIBUTIONS CAN ADVANCE THE UNIVERSITY'S MISSION.

THE CSU ADHERES TO COMPENSATION PRACTICES THAT ARE FAIR AND EQUITABLE IN DESIGN, APPLICATION, AND DELIVERY.

THE COMPENSATION SYSTEM FOR THE CSU SHALL (A) BE ADMINISTERED IN A MANNER THAT COMPLIES WITH ALL APPLICABLE FEDERAL, STATE, AND LOCAL REGULATIONS AND LAWS, AND (B) BE CONSISTENT WITH APPLICABLE ADMINISTRATIVE POLICIES, RULES AND COLLECTIVE BARGAINING AGREEMENTS.
